20. An accident report will be completed and a copy provided to the parent for all accidents. In case of a serious accident a staff member will accompany the child to the hospital. The parent consents to the transportation of the child to the emergency department of the nearest hospital, by ambulance if necessary, with no liability to the staff of the Centre. In the event of an emergency, if the parent is not immediately available, an attending physician may hospitalize and/or secure treatment as deemed necessary.
